This submission is made on behalf of Shaun and Martine Huband of Griffin Road Investments by Horizon Surveying and Land Development in accordance with Clause 6 of Schedule 1 of the Resource Management Act 1991.

Introduction

This submission is made in relation to the sites at 137 Griffin Road, Maungaturoto, owned by Griffin Road Investments and 904 State Highway 12, Maungaturoto.

The sites are legally described as Lot 1 DP 79298, held in Record of Title NA 36A/897 and Part Allot 59 PSH of Wairau, held in Record of Title NA 35D/821.

Mr & Mrs Huband support the proposed rezoning of these sites to Rural Lifestyle Zone under the Proposed Kaipara District Plan (PDP).

Background

Mr & Mrs Huband are the landowners of both 137 Griffin Road, Maungaturoto, and 904 State Highway 12, Maungaturoto, adjoining rural properties located on the western edge of the Maungaturoto township.

The site forms a logical extension of the Maungaturoto township, positioned at the rural urban edge and will provide for a transitional zone between the township to the east and industrial areas to the west.


