Dear Council Members,

I am writing to formally submit my concerns regarding the proposed zone change and the two proposed subdivisions at Baylys Beach, currently under consideration by the Kaipara District Council.

1. Environmental and Ecological Impact

A primary concern relates to the significant pressure this level of development will place on the local environment and natural resources. Baylys Beach is a sensitive ecological area, and increasing residential density through subdivision and rezoning has the potential to:

- Exacerbate erosion and habitat degradation;
- Increase waste, stormwater, and runoff into surrounding natural waterways and marine environments;

Notably, one of the proposed subdivisions lies within a large water catchment area, and has two significant catchments for the Baylys beach area.

Given the intensifying impacts of climate change, this location raises serious questions about increased flooding, soil instability, and water management—both for the new developments and for existing properties further down the catchment, particularly those closer to the beachfront.

2. Stormwater and Infrastructure Concerns

We are particularly concerned about where stormwater runoff from these new developments will be directed. The existing environment is already under seasonal stress, and there is insufficient detail available to the public about the capacity or upgrades planned to support the additional load.

Improperly managed stormwater can:

- Lead to flooding during heavy rainfall events;
- Increase sedimentation and pollution in local watercourses;
- Damage existing private property.

These risks are heightened in a coastal area such as Baylys Beach, which is inherently vulnerable to changing weather patterns.



3. Water Supply and Resource Capacity

There is also the critical matter of water supply. Residents are frequently subjected to water restrictions during the summer months due to limited supply. The current system already struggles to meet existing demand. Any new development must demonstrate a sustainable, independent water supply solution before approval is granted. It would be irresponsible to proceed with further subdivision without first resolving these infrastructure shortfalls.

4. Demand for Development

We question whether there is genuine, community-supported demand for this scale of development in Baylys Beach. Anecdotal and historical data suggest a slow but steady pace of growth, which does not necessarily warrant significant rezoning or densification at this time.

Large-scale development in a relatively remote and environmentally sensitive location should be justified by robust, independently reviewed demand assessments, which should be made available for public scrutiny. Without clear evidence of need, the risk remains that this development is being driven by speculative or short-term commercial interest rather than long-term sustainable planning.

Conclusion

In light of the above, we respectfully request that Kaipara District Council:

- Pauses or declines the proposed zone change and subdivisions at Baylys Beach until comprehensive environmental impact assessments and infrastructure studies are completed;
- 2. Prioritises long-term environmental sustainability and community wellbeing over short-term development pressures.

We appreciate the opportunity to provide this feedback and trust that the Council will take the concerns of the local community into serious consideration when evaluating the proposal.
