#### Introduction:

The purpose of this report is to inform the Alcohol Regulatory and Licensing Authority of the general activity and operation of the Kaipara District Licensing Committee for the period 01 July 2024 to 30 June 2025. The report is pursuant to s.19 of the Sale and Supply of Alcohol (Fees) Regulations 2013.




# **Overview of the District Licensing Committees Workload**

#### 1.1 Noticeable increase or decrease in the TA's business:

The number of applications received by the Territorial Authority increased slightly in comparison with the previous year.



Applications determined by the District Licensing Committee increased from the previous year. The Mangawhai Food and Wine Festival has contributed to the increase in special licence applications.



This year three applications attracted either objections from members of the public or opposition from the reporting agencies.

- One application for an off licence was refused by the District Licensing Committee.
- An on licence and a renewal and variation of an off-licence application were resolved prior to the hearing date. The full committee met online to determine the applications.


#### Revenue:

The revenue paid to the Territorial Authority for application fees and annual fees continues to partly finance the inspectorate, administrative and committee components with regard to the preparing of all applications which must be determined by the District Licensing Committee.

A schedule of applications received is compiled monthly and sent to the Alcohol Regulatory and Licensing Authority (ARLA) in Wellington, together with a remittance to cover the proportion of fees due in terms of the Sale and Supply of Alcohol (Fees) Regulations SR 2013/452. Application and Annual fees payable to ARLA for the period 01 July 2024 to 30 June 2025 amounted to \$7521.00.


## **DLC** expenditure:

The Chair and members and associated costs for the 2024- 2025 financial year increased in comparison with previous years. Full committee hearings cost \$11,001.95 (applications that were either opposed or attracted objections from the public). Applications determined on the papers by the chair cost \$13,502.36.



The alcohol licensing team continues to spend considerable time on applications received by Council, to ensure great customer experience is given whilst ensuring consistency and compliance with the Sale and Supply of Alcohol Act 2012 are maintained.

There are 72 licences granted to premises in the Kaipara District as of the 30 June 2025. The Inspector is receiving enquiries regarding potential new premises within the Mangawhai, Paparoa and Dargaville areas and we are encouraging these types of proposed developments as best we can, including arranging on site meetings with new applicants and reporting agencies.



## 1.2 Agency meetings:

Meetings are usually held for the Kaipara Alcohol Accord on an as when required basis. These meetings are well supported by the licensees who have expressed their desire to continue to meet with agency representatives. The meetings are held and hosted at alternating venues to allow maximum licensee attendance across the district. One Accord meeting was held in person in June 2025 at Mangawhai and covered Gang Legislations and how it applies to licensed premises, training requirements and manger notifications.

From the agency perspective, the Licensing Inspectors, Police, Medical Officer of Health and Fire Service (Kaipara Management of Alcohol Group representation) continue to work together collaboratively in satisfaction of s.295 of the Sale and Supply of Alcohol Act 2012. The agencies have implemented a policy of meeting with prospective licensees for higher risk premises.

A Controlled Purchase Operations (CPO's) was carried out by the Medical Officer Health and the Police to test if licensees or their staff would sell to any minors with one grocery store failing the CPO.

Announced Compliance checks were conducted by Councils Environmental Health Officers or the Alcohol Licensing Inspector to all licensed premises. Unannounced visits to licensed premises were undertaken by the Licensing Inspector when required. This includes new operators and any premises that may be of concern.

# 1.3 Noticeable trends or issues faced by the Territorial Authority:

Monitoring and policing the alcohol control areas is vital to ensure compliance with the recently amended Alcohol Control Bylaw adopted by Council on 31 July 2024. The Bylaw amendments were improvements around clause placement, formatting and grammar.

# 2.1 New initiatives adopted or tried by the Territorial Authority:

The reporting agencies meet with prospective new licensees. This service aims to ensure that all prospective licensees fully comprehend the obligations and responsibilities under the Sale and Supply of Alcohol Act.

# 3 Sale of Alcohol Policy

# 3.1 Sale of Alcohol Policy and when last reviewed:

Kaipara district does not have a Local Alcohol Policy (LAP). The Territorial Authority continues to successfully work closely with the Police, Ministry of Health, Fire Service and other agencies to provide a joint collaborative and consistent approach when reporting on applications.

(NB - For Council to consider the implementation of a LAP, there would need to be evidence based statistical data directly linked to alcohol related harm within Kaipara district. To date no evidence has proven conclusive to necessitate the progressing of a LAP for Kaipara district).

#### 4 Enforcement and Inspections

# 4.1 Alcohol-related Bylaws:

As previously referred to, the Alcohol Control Bylaw 2018 was reviewed in 2024. Police are responsible for monitoring the alcohol control areas in Mangawhai, Dargaville, Ruawai, Kaihu, Aranga, Omamari, Baylys Beach, Glinks Gully, Pouto, Te Kopuru and Tinopai.

# 4.2 Summary of inspections undertaken of licensed premises:

Compliance checks of licensed premises were undertaken by the warranted licensing inspectors.

Licensed premises have been subject to inspections as and when required with the aim of visiting 100% of all licensed premises annually and this was achieved for the year 2024-2025.

# 5 Liaison with Other Agency Groups

# 5.1 Accord Liaison Group Meetings:

The Kaipara Alcohol Accord continues to meet, and the attendance is strong from a cross-section of licensees across the district representing hotels, taverns, bottle stores, supermarkets, grocery stores, restaurants and clubs. The Territorial Authority continues to facilitate the meetings and to encourage customer driven creative ideas targeting the reduction in alcohol related harm.

#### 5.2 Joint initiatives

The Inspectors continue to work closely with the Police, Public Health and the Fire Service in relation to inspections and any complaints lodged with the Territorial Authority. General checks for compliance are undertaken during both scheduled and impromptu visits to licensed premises. Joint agency / licensee meetings are held as required to resolve any issues of concern in a positive manner.

Police, Public Health, Fire Service and Inspectors from the Far North, Kaipara and Whangarei Councils are continuing to meet to discuss common issues and strategies for reducing alcohol harm in Northland.

## 6.1 An annual return for the Alcohol Regulatory and Licensing Authority (ARLA)

#### Conclusion:

The Alcohol licensing team has continued to work closely with licensees, manager's and reporting agencies whilst continuing to explore business improvement opportunities to ensure that all applications are processed in a timely manner. The formative setting of a regular weekly hearing date for unopposed applications for determination by the Committee Chair continues to provide for streamlined administrative procedures.

From a chair's perspective the DLC is well served by staff during 2024 - 2025. We have arrived at an operating system for uncontested applications which is low key, effective and efficient.
