## Decision (On the Papers)

This is for an application by Gary John Cameron on behalf of Lochiel Estate Vineyard and Winery for a Special Licence in respect of premises situated at Corner Moir and Insley Streets, Mangawhai Village, Kaipara District and known as the Mangawhai Village Library Hall.

The application is for the provision of alcohol as a free sample (tastings) on the premises and sale off the premises of the applicant's locally produced bottled table wine. The duration of the licence is from 07 November 2015 to 29 October 2016 inclusive of all Saturday Markets held between the hours of 9.00am and 3.00pm.

This application was made under section 138 of the Sale and Supply of Alcohol Act 2012 and is being determined by the District Licencing Committee under section 191(2) of the Act.

The application was referred to the Police, Medical Officer of Health and Inspector as relevant agencies for comment. No matters in opposition have been raised in respect of the applicant.

We are satisfied as to the matters to which we must have regard as set out in section 142 of the Act and we grant the applicant a Special Licence.

The licence will be subject to the following conditions:

a) The steps detailed in the application form must be taken by the licensee to provide assistance with or information about alternative forms of transport from the licensed premises.

- b) The steps as detailed in the application form must be taken by the licensee to promote the responsible consumption of alcohol.
- c) At all times when alcohol is being provided free as a sample on the premises (tasting) drinking water must be freely available.
- d) The following steps shall be taken by the licensee to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
  - The Manager/s to be on duty at all times. Host responsibility techniques to be applied to ensure no intoxication. No sale of alcohol to minors or intoxicated persons allowed.
- e) Members of the public shall be excluded from the premises in the following circumstances:
  - · If an intoxicated or otherwise prohibited person under the Act.
- f) Alcohol may only be served in the following containers:
  - Tastings shall be provided in a 10-25ml serve with a maximum of five tastings per customer.
  - · All sales shall be by way of unopened bottles in sealed containers.
