Decision (On the Papers)

This is for an application by Stephanie Marie Spraggon for a Special licence in respect of premises situated at 37 Hokianga Road, Dargaville, Kaipara District and known as the Dargaville Town Hall. The application is for the Wedding Celebration between Stephanie Marie Spraggon and Brett Pattison to be held on Saturday 19 December 2015 from 4.00pm until 12.00 midnight

This application was made under section 138 of the Sale and Supply of Alcohol Act 2012 and is being determined by the District Licencing Committee under s.191(2).

It is noted that there is no intention to sell alcohol on this occasion; rather that the applicant intends to supply a limited amount of beer and wine to guests who will also be permitted to bring their own alcohol refreshments to the Wedding Celebration. With regard to the hiring of the venue, it is a requirement of tenure that if alcohol is being consumed within the premises that the hirer apply for and be granted a Special Licence by the Territorial Authority for the duration of the occasion.

Under s.213(2) of the Act we exempt the holder of the Special Licence from having to appoint at least one certified Manager and instead appoint Tarati Dolecia Williams, Michelle Tina Pattison and Isobel Hutchins as responsible persons for the Wedding celebration between Stephanie Marie Spraggon and Brett Pattison.

The application was referred to the Police, Medical Officer of Health and Inspector for comment. No matters in opposition have been raised in respect of the application.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act and we grant the applicant a Special Licence.

Alcohol may be sold or supplied under the licence only on the following days and during the following hours:

Saturday 19 December 2015 from 4.00pm to 12.00 midnight

The licence will be subject to the following conditions:

- a) The licensee shall have available for consumption on the premises, at all times when alcohol may be sold or supplied under the licence, a reasonable range of non-alcoholic refreshments.
- b) A variety of substantial foods shall be available as detailed by the applicant for consumption on the premises at all times when the premises are authorised to be open for the sale or supply of alcohol. The range of food will include a full menu covering entrees, main meals, desserts and supper and will include a selection of sausage and spring rolls, crustini's, chips and dips and cheese, fruit and meat platters. Mains will include a selection of roast pork, mutton, chicken and ham, seafood, vegetables, salads and breads. Dessert will include a selection of cake, pavlova, ice cream, fruit salad and cheesecake. Supper will include cakes, slices and savouries.
- c) Low-alcohol beverages of the nature stated on the application form, must be available for sale or supply on the premises at all times when the premises are authorised to be open for the sale or supply of alcohol.
- d) Drinking water be freely available to all customers at all times that the premises are open for the sale or supply of alcohol. 'Freely available' to customers, in relation to water, means -
 - (i) Supplied free in clean drinking vessels on request; or
 - (ii) Available free in larger containers from which it may be easily poured or drawn by customers, together with clean drinking vessels that are also available free nearby; or
 - (iii) Available free from a tap to which customers have easy access, together with clean drinking vessels that are also available free nearby.

- e) The steps detailed in the application form must be taken by the licensee to provide assistance with or information about alternative forms of transport from the licensed premises.
- f) The steps as detailed in the application form must be taken by the licensee to promote the responsible consumption of alcohol.
- g) The following steps shall be taken by the licensee to ensure that the provisions of the Act relating to the sale or supply of alcohol to prohibited persons are observed:
 - The responsible persons to be on duty at all times.
 - Host responsibility techniques to be applied to ensure no intoxication.
 - No sale or supply of alcohol to minors or intoxicated persons allowed.
- h) Members of the public shall be excluded from the premises in the following circumstances:
 - If an intoxicated or otherwise prohibited person under the Act.
- i) Alcohol may only be served in the following containers:
 - Beer shall be by way of single serve glassware as supplied by the premises or single serve 330ml bottles or 750ml shared bottles.
 - Wine shall be by way of single serve glassware as supplied by the premises or 750ml shared bottles.
