We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act and we grant the applicant a Special Licence.

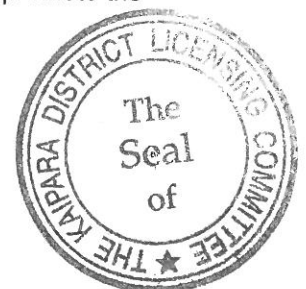
In addition to Emma Victoria Gray as Manager for the event, we also appoint under s.213(2) of the Act Gillian Hill, Christine Bygrave, Gaylene Lawrence, Keith Coleman, Brenda Coleman, Lyn Johnston as responsible persons for the event.

Alcohol may be sold or supplied under the licence only on the following days and during the following hours:

- **Saturday 19 March 2016 from 6.30pm to 9.00pm.**

The licence will be subject to the following conditions:

- The licensee shall have available for consumption on the premises, at all times when alcohol may be sold or supplied under the licence, a reasonable range of non-alcoholic refreshments.
- A variety of substantial foods shall be available as detailed by the applicant for consumption on the premises at all times when the premises are authorised to be open for the sale and supply of alcohol. The range of food will include a selection of cheese and crackers, sausage rolls, breads and dips, sandwiches.
- Low-alcohol beverages of the nature stated on the application form, must be available for sale or supply on the premises at all times when the premises are authorised to be open for the sale and supply of alcohol.
- Drinking water be freely available to all customers at all times that the premises are open for the sale and supply of alcohol. 'Freely available' to customers, in relation to water, means –
 - Supplied free in clean drinking vessels on request; or*
 - Available free in larger containers from which it may be easily poured or drawn by customers, together with clean drinking vessels that are also available free nearby; or*
 - Available free from a tap to which customers have easy access, together with clean drinking vessels that are also available free nearby.*
- The steps detailed in the application form must be taken by the licensee to provide assistance with or information about alternative forms of transport from the licensed premises.
- The steps as detailed in the application form must be taken by the licensee to promote the responsible consumption of alcohol.



- g) The following steps shall be taken by the licensee to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
- One Manager or responsible person to be on duty at all times.
 - Host responsibility techniques to be applied to ensure no intoxication.
 - No sale or supply of alcohol to minors or intoxicated persons allowed.
- h) Members of the public shall be excluded from the premises in the following circumstances:
- If an intoxicated or otherwise prohibited person under the Act.
- i) Alcohol may only be served in the following containers:
- Tastings shall be provided in a maximum 30ml serving cup with no more than five tastings per customer.
 - Beer shall be by way of single serve 330ml bottles or in single serve glassware as supplied by the premises.
 - Wine shall be by way of single serve glassware as supplied by the premises.
 - All off sales shall be by way of unopened bottles in sealed bags. Bottle size may vary between 330ml and 750ml.
