## Decision (On the Papers)

This is for an application by Lloyd Douglas Redfern-Hardisty on behalf of Mangawhai Boating and Fishing Club Incorporated for a special licence in respect of premises situated at 1 Alamar Crescent, Mangawhai Heads, Kaipara District and known as the Mangawhai Boating and Fishing Club. The application is made in respect of various club fishing and prize giving events, the Club Christmas Dinner and the Club AGM to be held between 22 October 2016 and 05 August 2017. This application was made under section 138 of the Sale and Supply of Alcohol Act 2012 and is being determined by the District Licencing Committee under section 191(2).

The application was referred to the Police, Medical Officer of Health and Inspector for comment. No matters in opposition have been raised in respect of the application.

Linda Otter, Jeanette Stewart, Lyn Buchanan and Ken Davies shall be appointed to manage the events in accordance with section 213 (1) of the Act.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act and we grant the applicant a Special Licence.

The licence will be subject to the following conditions:

a) Alcohol may be sold under the licence only on the following days and during the following hours:

Saturday 22 October 2016 from 4.00 pm to 9.00 pm
Sunday 23 October 2016 from 3.00 pm to 9.00 pm
Monday 24 October 2016 from 3.00pm to 8.30pm
Saturday 10 December 2016 from 4.00pm to 10.30pm
Saturday 14 January 2017 from 4.00pm to 10.30pm
Saturday 28 January 2017 from 4.00pm to 9.00pm
Sunday 5 February 2017 from 4.00pm to 9.00pm
Monday 6 February 2017 from 3.00pm to 8.30pm
Friday 14 April 2017 from 4.00pm to 10.00pm
Saturday 03 June 2017 from 4.00pm to 9.00pm
Sunday 04 June 2017 from 3.00pm to 9.00pm
Monday 05 June 2017 from 3.00pm to 8.30pm
Saturday 5 August 2017 from 3.00pm to 8.30pm.

- b) The licensee shall have available for consumption on the premises, at all times when alcohol may be sold under the licence, a reasonable range of non-alcoholic refreshments.
- c) A variety of substantial foods shall be available as detailed by the applicant for consumption on the premises at all times when the premises are authorised to be open for the sale and supply of alcohol. The range of food will include a BBQ with salads and hot vegetables, burgers, sausages, hot chips, toasted sandwiches, and a spit roast.
- d) Low-alcohol beverages of the nature stated on the application form, must be available for sale and supply on the premises at all times when the premises are authorised to be open for the sale of alcohol.

- e) Potable drinking water is to be freely available to all customers at all times that the premises are open for the sale and supply of alcohol. 'Freely available' to customers, in relation to water, means –
  - i. Supplied free in clean drinking vessels on request; or
  - Available free in larger containers from which it may be easily poured or drawn by customers, together with clean drinking vessels that are also available free nearby; or
  - iii. Available free from a tap to which customers have easy access, together with clean drinking vessels that are also available free nearby.
- f) The steps detailed in the application form must be taken by the licensee to provide assistance with or information about alternative forms of transport from the licensed premises.
- g) The steps as detailed in the application form must be taken by the licensee to promote the responsible consumption of alcohol.
- h) The following steps shall be taken by the licensee to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
  - i. One Manager to be on duty at all times.
  - ii. Host responsibility techniques to be applied to ensure no intoxication.
  - iii. No sale of alcohol to minors or intoxicated persons allowed.
- i) Members of the public shall be excluded from the premises in the following circumstances:
  - i. If an intoxicated or otherwise prohibited person under the Act.
- j) Alcohol may only be served in the following containers:
  - i. Beer shall be by way of single serve 330ml bottles.
  - Wine shall be by way of single serve glassware as supplied by the premises and 300ml bottles.
  - iii. RTDs shall be by way of single serve 330ml bottles.
