Decision (On the Papers)

This is for an application by Benjamin Lewis Sheppard on behalf of the Pahi Boating and Fishing Club Incorporated for a Special licence in respect of premises situated at 680 Pahi Road, Pahi, Kaipara District and known as the Pahi Reserve. The application is for the Annual Pahi Boating Regatta to be held on Friday 27 January 2017 from 6.00pm to 11.00pm, Saturday 28 January from 10.30am to 1.00am the following day and Sunday 29 January 2017 from 10.30am to 1.00am the following day.

This application was made under section 138 of the Sale and Supply of Alcohol Act 2012 and is being determined by the District Licensing Committee under section 191(2).

The application was referred to the Police, Medical Officer of Health and Inspector for comment. No matters in opposition have been raised in respect of the application.

In addition to Justin Healey being named as the certified Manager for the event, Benjamin Lewis Sheppard, Ryan Sheppard, Mike Donald, Leah Greenhill, Jacqui Donald, Kaine Ross, Kurt Hyndman and Natalia Hutchings are appointed as responsible persons pursuant to s.213(2) and may be rostered as bar staff any time that the premises is open for the sale and supply of alcohol.

We are satisfied as to the matters to which we must have regard as set out in s.142 of the Act and we grant the applicant a Special Licence.

Alcohol may be sold under the licence only on the following days and during the following hours:

- Friday 27 January 2017 from 6.00pm to 11.00pm
- Saturday 28 January 2017 from 10.30am to 1.00am the following day
- Sunday 29 January 2017 from 10.30am to 1.00am the following day.

The licence will be subject to the following conditions:

- a) The licensee shall have available for consumption on the premises, at all times when alcohol may be sold under the licence, a reasonable range of non-alcoholic refreshments.
- b) A variety of substantial foods shall be available as detailed by the applicant for consumption on the premises at all times when the premises are authorised to be open for the sale and supply of alcohol. The range of food will include a selection of hot chips, hot dogs, hamburgers, sandwiches, pies, cakes, sausage rolls, savories, mussel fritters. A roast meal shall be available on the Saturday night.
- c) Low-alcohol beverages of the nature stated on the application form, must be available for sale and supply on the premises at all times when the premises are authorised to be open for the sale of alcohol.
- d) Drinking water be freely available to all customers at all times that the premises are open for the sale and supply of alcohol. 'Freely available' to customers, in relation to water, means -
 - (i) *Supplied free in clean drinking vessels on request; or*
 - (ii) *Available free in larger containers from which it may be easily poured or drawn by customers, together with clean drinking vessels that are also available free nearby; or*
 - (iii) *Available free from a tap to which customers have easy access, together with clean drinking vessels that are also available free nearby.*



- e) The steps detailed in the application form must be taken by the licensee to provide assistance with or information about alternative forms of transport from the licensed premises.
- f) The steps as detailed in the application form must be taken by the licensee to promote the responsible consumption of alcohol.
- g) The following steps shall be taken by the licensee to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - The named certified Manager or one responsible person to be rostered on duty at all times.
 - Host responsibility techniques to be applied to ensure no intoxication.
 - No sale of alcohol to minors or intoxicated persons allowed.
- h) Members of the public shall be excluded from the premises in the following circumstances:
 - If an intoxicated or otherwise prohibited person under the Act.
- i) Alcohol may only be served in the following containers:
 - Beer shall be by way of 300ml-350ml single serve bottles.
 - Wine and spirits shall be by way of single serve 300ml plastic cups or PETS.
 - Spirits shall be by the way of a single serve 300ml plastic cups.
 - Premix/RTD's shall be by way of depressurized single serve cans.
- j) The whole of the premises is designated as a supervised area.
