- 1. This is a further submission in support of submissions on Private Plan Change 84 proposed to the Operative Kaipara District Plan (the Plan Change):
- 2. The Director-General of Conservation (the D-G) represents relevant aspects of public interest and has interest in the Plan Change that is greater than the general public. The D-G has all the powers reasonably necessary to enable the Department of Conservation to perform its functions<sup>1</sup>. The Conservation Act 1987 sets out DOC's functions which include (amongst other things) management of land and natural and historic resources for conservation purposes, preservation so far as is practicable of all indigenous freshwater fisheries, protection of recreational freshwater fisheries and freshwater fish habitats and advocacy for the conservation of natural resources and historic heritage<sup>2</sup>. Section 2 of the Conservation Act defines 'conservation' to mean 'the preservation and protection of natural and historic resources for the purpose of maintaining their intrinsic values, providing for their appreciation and recreational enjoyment by the public, and safeguarding the options of future generations'.
- 3. I have outlined my views on specific submissions in the attached table in the required format. Strict measures need to be taken to protect the critical habitat of tara iti from the cumulative effects of intensive development in the catchment of Mangawhai Harbour and potential increases in turbidity affecting their ability to successfully feed. The Department of Conservation would be pleased to assist the Council and applicant to mitigate these concerns.
- 4. I <u>do not</u> wish to be heard in support of my further submission.
