It's impossible to make an informed decision regarding the true impact and effects of a development of this size on our community and whether the surrounding areas can actually support a development of this size without detailed information.

6.1 PPC84 in whole - oppose:

* Uncertainty over legislative framework
* Lack of development strategy in relation to wastewater scheme. The submitter is concerned that PPC84 has lacks an overall development strategy. The submitter views there is uncertainty over the wastewater scheme, and whether the Kaipara District Council will be extending the catchment area to cover the PPC84 area.
* Mangawhai Central - The submitter is concerned PPC84 has not sufficiently considered how infrastructure will be upgraded. The submitter references Mangawhai Central in which they view went ahead prematurely given that wastewater capacity was not met prior to development, and the submitter is concerned PPC84 will have the same issue.
* Financial Burden of Developments - The submitter is concerned that the cost of development in respect to infrastructure connections and potential upgrades will fall to the ratepayers.
*Public Services, Amenities and Sustainability - The submitter is concerned that the plan change is reliant on outdated documents and views that the PPC84 process is ad hoc. The submitter notes that in future the community would ideally have more of a say in how the development should proceed and that this would be better served through a fundamental change the operative DP allowing the community to have a say on the broader significance of future development, planned infrastructure and the effects on the amenities of the township.
* Cumulative Effect of Development - The submitter is concerned with the number of proposed ad hoc developments which will result in thousands of new residential dwellings. The submitter is concerned the vast increase in residents will lead to further stain and could overwhelm infrastructure and amenities.

The submitter seeks the requested relief given there is an abundance of native planting in the area which a lot of birds use as nesting, as well as a flight connection path to the estuary and other habitats. This strip of land is also well utilised for exercise and dog walking.

## The reasons for my

State, in summary, the nature of your further submission giving clear reasons: (you are welcome to type this information in a separate document and attach the document to this form when you submit it to our office) I strongly support the submitter's recommendation that the current paper road above/adjacent to Kahu Drive and Daphne Place that is included in the zone change to be retained as green space instead of converted to residential housing and/or a busy connection road from Cove Road to Moir Street.

There is potential to create "green connectivity" routes in/around Mangawhai and rather than convert one of the few remaining unimpeded ridge lines around Mangawhai with buildings and/or busy roads, it would be beneficial to protect the green space and encourage bird life with carefully considered low set native plantings and a potential walking/cycle pathway.
