The submitter is concerned that sites zoned as rural and remaining as rural will receive complaints about these uses from future urban uses within the proposed plan change areas. An objective and policy to address reverse sensitivity to avoid complaints from neighbours about adjacent farming is requested. This is supported by Riverside and their position that a no-complaints covenant via zone standards will be required to protect the on-going operation of Riverside Holiday Park from adjoining sites, including the proposed 'Rural Lifestyle Zone'.
