- There is a side agreement in which Northland Regional Council commits to undertake flood mapping of the priority catchments in our District (Paparoa and Dargaville/Ruawai)
- Remaining challenges particularly around development in Dargaville
- Flood mapping is key to understanding the nature of the risk. For Dargaville/Ruawai not just rainfall, it is also storm surge, rainfall, tidal and silting up of the river.

- Submissions on the Long Term Plan Consultation Document close on Friday 27 March.
- Some issues raised at the public meetings were more in the Northland Regional Council's jurisdiction. These will be passed on appropriately.



- The MCWWS Advisory Panel will have an Open Day on Easter Saturday.
- The accountability workstream is very busy in the discovery phase.
- First Court action on rates recovery will be on 30 June to 01 July with consolidated group led by B and H Rogan.
- Council has applied to join the LGFA.
- Capital expenditure on roads and footpaths is expected to be at around 80% up to date by year end. An application has been made to NZTA to allow carry-over of the remaining 20%.
- Growth in the number of building and resource consents is mainly happening in the east.
- That most of the increased water usage in Maungaturoto is Fonterra generated.
 Increasing demand will likely be beyond our consent limits so discussions on this have begun.
- That it would be useful to see the new service request reports including what the resolutions were.
- That the debt ratio is now very healthy and tracking well against LTP.
- How the targeted rate in Mangawhai that is for the Harbour Restoration Society is accounted for.
- Pleasing to see outstanding rates have come down to a manageable figure.
