2 Long Term Plan 2015/2025 Consultation Document Deliberations

2.1 Overview of Feedback Process

Community Engagement Manager 2303.19.01

A copy of the Community Engagement Manager's report "Overview of Feedback Process" dated 13 May 2015 was circulated.

Discussion Points:

- That the interest and inflation rate projections were based on BERL and PWC estimates.
 Noted that staff had taken a conservative approach.
- That the work planned for forestry roads will maintain the existing level of service however will cost more due to the heavier loading.
- That mobility access must be considered when planning footpath work.
- That deferred roading expenditure may result in the loss of subsidy. The assumption in the Plan was that all deferred work will in time get a subsidy.
- That Council had the legal right to charge a forestry roading targeted rate.
- That other Council's use a forestry differential rather than a targeted rate.
- That street trees were important and Council should maintain them.
- That if there was any discretionary funding it should be spent on roads.
- That social housing maintenance must be prioritised.

Moved Robertson / Winder

That Kaipara District Council:

- 1 Receives the Community Engagement Manager's Report "Long Term Plan 2015/2025 Consultation Document Deliberations: Overview of Feedback Process", and its Attachments 1 to 8, dated 13 May 2015; and
- 2 Believes it has complied with the decision-making provisions of the Local Government Act 2002 to the extent necessary in relation to this decision; and in accordance with the provision of section 79 of the Act determines that it does not require further information prior to making a decision on this matter; and
- Receives the feedback and determines that it has considered all feedback, both written and verbal, to the Council's Consultation Document for the Long Term Plan 2015/2025; and
- Instructs the Chief Executive to respond to all those persons/organisations that provided feedback including the responses to feedback points as noted in Attachments 1 through 8 to the Community Engagement Manager's Report "Long Term Plan 2015/2025 Consultation Document Deliberations: Overview of Feedback Process"; and
- Notes that where appropriate the feedback has been entered into Council's Service Request for operational resolution of the matter raised; and



6 Makes the following decisions as a result of the matters raised by the feedback and the reasons for such decisions:

a) Rates Increases and Debt Management

Directs the Chief Executive to maintain the current proposal for rates increase and debt management for the finalisation of Council's Long Term Plan 2015/2025; and

b) Three Waters, Roads and Footpaths, Parks and Reserves

- 1 Makes no changes as a result of feedback to the current proposals and funding sourced from rates for:
 - Three Waters
 - Roads and Footpaths
 - Parks and Reserves; and

c) Forestry Roading Targeted Rate and Funding from NZ Transport Agency

Notes as for 6b) above, while there is no change to the amount funded through the Forestry Roading Targeted Rate in the Long Term Plan 2015/2025 (local share), there are changes in the NZ Transport Agency funding programme which are addressed in the report to Council "Long Term Plan 2015/2025 Consultation Document Deliberations: Financial Changes" dated 12 May 2015; and

d) Parks and Reserves

- Notes that there were requests for Council to undertake work in support of various matters, and
- Instructs the Chief Executive to continue to try and engage with the community of Te Kopuru to take leadership of the Domain. That should the community not engage, then this is reported back to Council and the toilets should be closed; and
- Instructs the Chief Executive to create a policy on street trees that includes consultation with Northland Regional Council to ensure that the type and placement of the tree is appropriate; and

e) Community Development Fund

1 Increases the Community Development Fund to \$125,000 for the years 2015 to 2025 being the length of this Long Term Plan; and

f) Fees and Charges

- Introduces a \$10.00 discount for working dogs thereby reducing their fee to \$50.00 per dog unless the dogs are registered late at which point the late fee would apply; and
- 2 Introduces a \$10.00 discount for owners with large numbers of dogs (over 20) thereby reducing their fee to \$50.00 per dog unless the dogs are registered late at which point the late fee would apply; and



- 3 Reduces the increase from \$15.00 to \$10.00 for the Mangawhai community housing rental to \$140.00 per week; and
- 4 Future community housing charges are to automatically increase by CPI plus minor rounding; and
- Introduces a \$300.00 Food Control Plan fee for the assessment of these plans which are required as part of the transition to the new legislation; and
- Introduces a simple fees structure for both inspections and audits with inspections increasing 15% rather than 10% as in the draft Fees and Charges and 5% for the audit from the fees set in the 2014/2015 financial year; and
- 7. Instructs the Chief Executive to make changes arising from the above decision-making process as they may relate to the Long Term Plan 2015/2025; and
- 8. Instructs the Chief Executive that any surplus capacity within the parameters set in 6(a) be allocated to the maintenance of roads to the extent possible; and
- 9. Thanks the Chief Executive and staff for the work put into this document.

A copy of the Financial and Corporate Planning Manager's report, "Long Term Plan 2015/2025 Consultation Document Deliberation: Financial Changes" dated 12 May 2015 was circulated.

Discussion Points:

- That some roading subsidies may be lost however Council plans to spend the local share on roading despite this loss which may result in a reduced roading programme.
- That salary increases were largely due to reduced contractor work bringing expertise in-house.
