#### **Summary**

Section 33(5)(b) of the Te Uri o Hau Claims Settlement Act 2002 states that the Minister of Conservation must 'appoint one of the 3 persons appointed by Te Uri o Hau governance entity as chairperson of the joint administering body and with a casting vote'.

At the Harding Park and Pout Tu Te Rangi Joint Management Committee's meeting on 21 November 2017, the Committee nominated Rex Nathan as the Chair pending confirmation from the Minister of Conservation.

Council wrote to the new Minister of Conservation Hon Eugenie Sage on 11 January 2018 requesting that Rex Nathan be formally appointed as the Chair of the Committee (**Attachment 1**).

On 21 February 2018, Council received a letter from Hon Eugenie Sage appointing Rex Nathan as the Chair of the Committee (Attachment 2).

#### Recommendation

That the Harding Park and Pou Tu Te Rangi Joint Management Committee:

- 1 Receives the Administration Assistant's report 'Appointment of Chair Rex Nathan by the Minster of Conservation' and its attachments dated 27 February 2018; and
- Notes the Minister of Conservation's appointment of Rex Nathan as the Chair of the Harding Park and Pou Tu Te Rangi Joint Management Committee with a casting vote for the remaining term of the Kaipara District Council.

#### Reason for the recommendation

Committee members are informed about matters relating to the Committee's governance.

#### Reason for the report

Council received a letter from the Minster of Conservation formally appointing Rex Nathan as the Chair of the Committee.

#### **Background**

There are two separate entities at play with the appointment of Chair of this Committee.

The Pou Tu o Te Rangi Joint Management Committee was established by the Minister of Conservation on 03 July 2006 to govern the Pou Tu o Te Rangi Pa site.



The Harding Park Committee was established by Council on 27 May 2014 to hold combined meetings with the Pou Tu o Te Rangi Joint Management Committee to 'allow for unified management of all the lands included under the Pou Tu o Te Rangi and Harding Park Reserve Management Plan'. The 2014 report to Council described the co-governance structure and noted that '[d]ecisions [are to be] made by the same members at the same meetings despite two legal entities'.

Following the triennial local body elections 2016, Mayor Greg Gent re-established the Harding Park Committee. Pursuant to section 33(5) of the Te Uri o Hau Claims Settlement Act 2002, Te Uri o Hau nominated three members, and one of these three members must be appointed as Chair according to the same legislation.

Consequently, Rex Nathan was nominated by the Committee on 21 November 2017 and was formally appointed as the Chair by the Minister of Conservation in a letter dated 21 February 2018.

#### Factors to consider

#### Community views

The community expects Council and its Committees to operate with a clear governance structure.

#### **Policy implications**

The recommendations in the report is not considered 'Significant' under the Council's Significance and Engagement Policy.

#### Financial implications

There are no financial implications.

#### Legal/delegation implications

The Chair of this Committee must be appointed by the Minister of Conservation under the Te Uri o Hau Claims Settlement Act 2002. Delegations to the Harding Park and Pou Tu Te Rangi Joint Management Committee will remain the same. The Committee's Terms of Reference will be amended to reflect the appointment of Rex Nathan as Chair.

#### **Next step**

Amended Harding Park and Pou Tu Te Rangi Joint Management Committee's Terms of Reference will be brought to Council's meeting on 28 March 2018 for approval.

#### Appointment of Chair to the Harding Park and Pou Tu Te Rangi Joint Management Committee

Section 33(5) of the Te Uri o Hau Settlement Act 2002 requires that:

- '(5) Despite subsection (3), the Minister of Conservation must
  - (a) appoint a joint administering body for Pou Tu o Te Rangi comprising 3 persons nominated by Te Uri o Hau governance entity and 3 persons nominated by the Kaipara District Council; and
  - (b) appoint one of the 3 persons appointed by Te Uri o Hau governance entity as chairperson of the joint administering body and with a casting vote.'

This 'Pou Tu o Te Rangi Joint Management Committee' was established by the Minister of Conservation on 03 July 2006 comprising three members nominated by Kaipara District Council and three members nominated by Te Uri o Hau.

At its meeting on 21 November 2017, the Harding Park and Pou Tu Te Rangi Joint Management Committee was asked to select a Chair. The Committee nominated Rex Nathan.

A copy<sup>i</sup> of the full minutes is included with this letter for your reference.

In light of the above, it is requested that the Minister of Conservation formally appoint Rex Nathan to be the Chair of the Harding Park and Pou Tu Te Rangi Joint Management Committee and with casting vote. Rex Nathan is one of the three persons appointed by Te Uri o Hau governance entity to be a member of the Pou Tu Te Rangi Joint Management Committee.

#### **Summary**

The Harding Park Committee has been established to work alongside the Pou Tu Te Rangi Joint Management Committee to implement the adopted 2002 Pou Tu Te Rangi and Harding Park Reserve Management Plan (RMP).

There is a \$100,000 capital works budget available in 2017/2018 to implement the Works Programme that was approved in September 2017.

A summary of activities, operations and maintenance work carried out over the months of November 2017 to January 2018 is reported below.

A change in reporting lines means that the Park will now fall under the Infrastructure Department. The Chief Operating Officer and General Manager Infrastructure Curt Martin will attend future Committee meetings, with Mike Collins continuing as the Parks Officer for the Park.

#### Recommendation

That the Harding Park Committee and Pou Tu Te Rangi Joint Management Committee receives the Community Relationships Manager's report 'Operations Update: December 2017—February 2018' dated 26 February 2018 and the information contained therein.

#### Reason for recommendation

This will keep the Committee up-to-date on progress and relevant information regarding the ongoing operations and implementation of the Pou Tu Te Rangi and Harding Park Reserve Management Plan.

# Reason for the report

To report on the operations by providing an update for the December 2017—February 2018 period and the 2017/2018 Works Programme.

#### **Background**

The Harding Park and Pou Tu Te Rangi Joint Management Committee (the Committee) is charged with implementing the July 2012 Pou Tu Te Rangi and Harding Park Reserve Management Plan (RMP).

The adoption of the RMP signals the start of a new phase for this site and its wider surrounds. It is intended that any future development or land-use decisions must recognise the RMP's shared vision/goals for Harding Park and Pou Tu Te Rangi Pa (Park and Pa site).



#### **Operations update**

Council has approved \$100,000 per annum capital works and the Committee adopted the 2017/2018 Works Programme in September 2017.

#### **General matters**

A successful Community/Council event was held on 06 December 2018 to tidy the gardens outside the Museum with almost 30 participants.

Council's Roading Engineer has checked the feasibility of a 'bypass'. A Council contractor, Broadspectrum, has been asked to provide prices for the options of a bypass verses a bollard system.

#### Factors to consider

#### Community views

The RMP was developed using a public process and reflects the views of the community and other stakeholders at the time of its development. The Park and Pa site is popular with locals and visitors to the area. The site, particularly the Museum, is considered to be amongst Dargaville's greatest attractions. Public interest in any decision relating to governance of this area is therefore high.

#### **Policy implications**

There are no policy implications as all recommendations are consistent with the RMP.

#### Financial implications

It is the Chief Operating Officer and General Manager Infrastructure's responsibility to ensure all operations are conducted within budget. The financial budgets are set within the Long Term Plan and respective Annual Plan.

#### Legal/delegation implications

There are no delegation issues: the Harding Park Committee has delegated authority from Council to govern Harding Park in accordance with its Terms of Reference.



# Assessment of significance

This is not a significant activity on Harding Park and as such is not considered to be significant in terms of Council's Significance and Engagement Policy.
